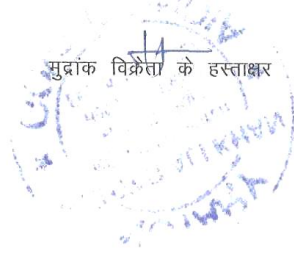

2. AREAS OF COOPERATION

3. IMPLEMENTATION

- a. Any specific programs or activities implemented under the terms of this Memorandum of Understanding shall be mutually agreed upon in writing
- b. Each of the participating institutions shall be fully responsible financially for the activities carried out under its directions or by its staff, except as otherwise agreed by the parties.
- c. The parties will designate one officer each who will develop and coordinate specific programs or activities between them.

4. DURATION AND RENEWAL OF AGREEMENT

This Memorandum of Understanding will become effective immediately from the date of signing of this MOU for a period of five (05) years. The institutions may extend the term by mutual written agreement.



5. AMENDMENTS

This memorandum of Understanding may be amended by a written agreement signed by the authorized representative or Principal/Head of both the institutions.

6. TERMS

- a. The parties agree not to discriminate on the basis of religion, race, creed, nationality of ethnic origin, sex, age handicap, political affiliation, sexual orientation, disability or status as a veteran.
- b. None of the parties shall use the name, logo, likeness, trademarks, image or other intellectual property of either of the other parties for any advertising marketing, endorsement or any other purpose without specific prior written consent of an authorized representative of the other party and the each such use.

7. JURISDICTION OF THE MOU

- a. Both parties agreed to solve any problem between themselves and in any unavoidable circumstances the judicial proceedings may be followed.
- b. In case of any disputes the judicial jurisdiction will be the court at Kota District .
